The Committee shall consist of five (5) persons, a majority of whom shall have a clearly-demonstrated interest in or knowledge of historic preservation and shall contain representation from one or more duly organized local historic preservation organizations. The Historic District Study Committee shall perform the duties and responsibilities as prescribe in Sections 3 and 14 of 1970 PA 169.
